I take responsibility for inspecting the playing area at each UOVA event in which I participate, and I hereby release, waive, discharge and covenant not to sue the Utah Outdoor Volleyball Association (UOVA), Tournament Directors or their employees, operators, promoters, officials, sponsors, advertisers, owners and lessees of premises used for UOVA events, other participants or and persons in the playing area, all for the purposes herein referred to as "Releasees", from all liability to the undersigned, his/her personal representatives, assigns, heirs, and net of kind for any and all damage, and any claim or demands thereof on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the Releasees or otherwise while the undersigned is in or upon the playing area or in any way competing, officiating, observing, working for, or for any other purpose participating in a UOVA event.

By my signature below, I hereby agree to indemnify and save and hold harmless the Releasees of any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the playing area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the Releasees or otherwise.

By my signature below, I hereby assume full responsibility for the risk of bodily injury, death or property damage due to the negligence of Releasees or otherwise while in or upon the playing area and/or while competing, officiating, observing, or working for, or for any purpose participating in the event.

By my signature below, I expressly acknowledge and agree that the activities at the vent an in the playing areas are potentially dangerous and could involve the risk of serious injury and/or death and/or property damage.
